Description of the program's connection to the institutional mission and goals:

Northern Oklahoma College, a multi-campus learning community, provides high quality, accessible, and affordable educational opportunities and services to allow citizens to develop to the full extent of their abilities, to succeed in a competitive global environment, and to be effective lifelong learners. Northern Oklahoma College will be recognized as an exemplary learning community that advances student success. - The Social Science division requires all fulltime faculty members to be available to students for advisement, tutoring, and any other academic issues.
- The Social Science degree and the Behavioral Science degree option have been carefully constructed so as to provide students with the most efficient transfer to area four year baccalaureate degree granting institutions.
- The Social Science division is committed to providing multiple venues for learning opportunities. Each of our courses is offered through Interactive Television and online learning venues.

- For the Social Science degree there are 12 hours of program requirements and 12 hours of recommended program elective.

The Social Science degree and Behavioral Science option degree of Northern Oklahoma College are transferable degrees that prepare student to pursue higher learning opportunities at baccalaureate degree granting institutions. The Social Science division also supports the general education goals of Northern Oklahoma College.

The Social Science degree is a transferable degree that will lead to a variety of career opportunities depending upon the specific baccalaureate path chosen. Career opportunities are as varied, as secondary social science teacher, social worker, psychologist, court advocacy, and each of the numerous helping careers.

According to the Occupational Outlook Handbook's Bureau of Labor Statistics, the following trends can be expected in fields related to this degree:

Psychologists with a master's degree can earn \$75,000 or more with a 10-19 percent growth rate expected.

Social workers with a bachelor's degree can expect to earn between \$35,000 and \$54,999 and sociologists with a master's degree can expect to earn between \$55,000 and \$74,999; these two careers also have a projected 10-19 percent growth rate.

Social and community service managers with a bachelor's degree can expect to earn between \$55,000 and \$74,000; this career area has a higher projected growth rate at 20-28 percent.

Secondary education teachers in this field can expect to see a lower projected growth rate at 0-9 percent with a median pay of \$35,000 to \$54,999 with a bachelor's degree.
